As we embark on this endeavor, we seek a partner who shares our vision, values, and passion for advocacy in advancing health equity for all in New Mexico. Together, we aim to elevate our advocacy strategy and brand, engage our audience, and inspire advocacy in action!

PROJECT OVERVIEW:

NMAHC seeks an independent contractor to engage New Mexico's County & Tribal Health Councils in the development of a community-driven plan for Substance Use Disorder (SUD) primary prevention. The Contractor will manage all project activities, provide technical assistance to Health Councils, and write a final report.

Project Period: July 1, 2024 - September 30, 2024

- 1. Develop and provide a 1-hour virtual session to introduce Health Councils to the project. The same session will be offered on 2 different dates.
- Design and use surveys and other mechanisms to collect insight on all Health Council Substance Use Disorder SUD primary prevention strategies and priorities for their communities.
- 3. Develop and implement methods to assess individual Health Councils' capacity, willingness, and understanding of SUD potential primary prevention interventions they want to make a priority in their communities.
- 4. Provide technical assistance to Health Councils as requested regarding this project.
- 5. Write a final report:
 - o Summarize findings for statewide priorities for SUD primary prevention intervention strategies.
 - o Summarize findings of Health Council champions that are ready and able to implement SUD primary prevention in their communities.
